

## Membership Meeting. May 26, 2021. Bank of Colorado.

**Roll Call.** Board Members Present: Nathan Sponseller, Tracy Ihnot, Mitch Swanda, Kim Shay, Sue Whittlesey, and Robbie Winne. Board Members Absent: Bill Long. Community Members Present: None.

Call to Order. President Swanda called the meeting of the membership and Board to order at 12:05 pm.

### Approval of Minutes.

Sponseller is posting the newsletter on Facebook and sharing to community message boards. The last e-newsletter reached over 400 people. Sponseller plans to set it up so that people can subscribe to the newsletter directly from Facebook. <u>Website</u>. The website project is still on hold for right now while other tasks are taking priority. <u>Food and Lodging Guide</u>. The guide needs to be updated for 2021. Sponseller will begin to work on this project soon. Board members discussed assisting with contacting businesses. <u>Colorado Grand Update</u>. Darnell Place-Wise is now the appropriate contact for scheduling events at the Fairgrounds. Sponseller will reach out to her to confirm the fairgrounds as the location for the event.
